

Skatepark Terms and Conditions

All members, guests, visitors and staff must adhere to the Terms and Conditions of LS-TEN at all times when on the premises.

The rules are for your safety and the safety of others. Failure to comply with the terms and conditions may lead to a ban from the park, or other appropriate action being taken by management.

Disclaimer: The risk of injury from the activities involved in these programmes is significant, including the potential for permanent disability and death, and while rules, equipment, and personal discipline may reduce this risk, the risk of serious injury does exist. All members and guests knowingly and freely assume such risks, both known and unknown, and assume full responsibility for their participation and for having and using the appropriate safety equipment and followed the conditions and etiquette of the Skatepark. We do not accept any responsibility for a member(s) or guest's failure to comply with these T&Cs other than due to our negligence.

1. All new members must complete an induction and review the park etiquette guide. If you have not had an induction or reviewed the park etiquette guide, it is your responsibility to make a member of staff aware before you participate.
2. We accept no responsibility for loss, theft or damage to any personal property brought onto the premises.
3. Payment must be made prior to participating in any session, non-payment will be treated as theft.
4. No food or drink is to be brought onto the premises for consumption in the building. Any food or drink which has not been purchased on the premises must be kept in a sealed container and consumed off the premises.
5. By Law, smoking is not allowed anywhere on the premises.
6. Due to the age of the building, extreme wet weather may cause some areas to be wet or damp. Staff will ensure that the park is safe for riders. If any members/ guests notice a wet/ damp area, do not use that area and report it to a member of staff immediately.
7. Anyone under 18 years of age wishing to use the park must have parental consent.
8. Children under the age of 12 must not be left unattended at any time by the responsible adult who brought them. It is the parent or guardian who is ultimately responsible for that child.
9. Anyone deemed intoxicated will be refused entry.
10. We reserve the right to refuse admission, remove a participant, or revoke membership at any time. Management decision is final.
11. Any abusive, violent, intimidating, dangerous, or anti-social behaviour (including bullying of any kind) will not be tolerated and may lead to perpetrators being removed from the park and receiving a ban.
12. It is a participant's responsibility to report any concerns they may have, or any misuse of the park they are aware of, to a member of staff. Staff are on-site at all times to help make your experience safe and enjoyable!
13. Prior to using any equipment, ramps or structures in the park participants should check it for safety and suitability for your purpose and skill levels. If you find any defect in the equipment you should immediately advise a member of staff who will rectify the fault.
14. Waxing of the park or graffiti will not be tolerated anywhere in the park. Members wishing to wax or to produce graffiti art should register their interest with the manager.
15. Any accident must be reported to a member of staff immediately. An accident book is available and any injury should be notified to staff, recorded and signed by the injured person or their representative immediately after the accident.
16. For safety reasons, pregnant women are not permitted to ride the park.
17. Participants are responsible for ensuring that their equipment is in good working order with no loose parts. Skateboards must not have sharp edges and must have sufficient deck grip, Scooter and bikes must have sufficient bar end covers.
18. Skateboarders under 13 years of age, Rollerbladers, Quad Skaters, Scooter users and BMX riders are required, and skateboarders 13 and over are encouraged, to wear an adequate helmet properly fastened at all times. All participants are encouraged to wear wrist, knee and elbow guards to minimise the risk of injury.
19. You agree to waive all liability claims against LS-TEN, its trustees, employees and volunteers for any injuries, ailments or other damage to yourself whilst using the facility other than due to our proven negligence.
20. Participants willingly agree to comply with the stated customary terms and conditions for participation. If a participant observes any significant concern in their readiness for participation they should remove themselves from participation and bring it to the attention of the nearest member of staff immediately.

Fire information

- Fire Exits and information about what to do in the event of a fire are displayed around the Skatepark. It is your responsibility to make yourself familiar with the procedures and the nearest fire exit. If you are unsure please ask a member of staff.
- Do not tamper with fire extinguishers or fire alarms or fire doors other than in the event of a fire. If you do, you will be banned and charged for any damaged caused.
